**Single Stage-two Envelope**

The Government of Azad Jammu & Kashmir through the Chief Engineer (PP&H) Building/ Public Health Engineering North intends to hire consultancy firms for resident construction supervision services for following project:

**i). Construction of Water Supply Scheme Bloach.**

1. Proposal is requested from consultancy firms registered with Pakistan Engineering Council (PEC) having adequate experience of performance on similar works along with qualified technical personnel.
2. Request for proposal (RFP) may be purchased from the office of **Executive Engineer, PWD Buildings / Public Health Engineering Division, Sudhnuti** from 3<sup>rd</sup> November, 2021 till 09<sup>th</sup> November, 2021 during office hours by interested eligible consultancy firms on submission of application along with copy of PEC Registration and upon payment of non-refundable fee of rupees two thousand five hundred only (PKR 2500/-).
3. The pre proposal meeting is scheduled on 27<sup>th</sup> October, 2021 in the office of the **Executive Engineer PWD Buildings/ PHE Division Sudhnuti**.
4. The deadline for submission of technical and financial proposals is 10<sup>th</sup> November, 2021 at 11:00 am. The proposals will be opened on the same day at 11:30 am in the presence of the consultants or their representatives who choose to attend in the Office of the **Executive Engineer, PWD Building/ PHE Division Sudhnuti**.
5. The selection process will be **"Quality Cum Cost Based Selection" (QCBS)**
6. The consultants should submit their proposals (One Original + One Copy) by hand in separate sealed envelope clearly marked as **"Technical Proposal"** and **"Financial Proposal"** keeping both in one sealed envelope.
7. The bid security @ 3% of bid price will have to be furnished in a sealed envelope in the **"Technical Proposal"** envelope and marked clearly as **"Bid Security"**. In case of any discrepancy in the bid security the financial proposal will be rejected and it will be ranked non-responsive.
8. Proposal received after deadline of submission of bids will not be entertained.
9. All other terms / conditions mentioned in Request for Proposal Documents shall also be fulfilled.
10. The Competent Authority in accordance with PPRA Rule-33 reserves the right to accept or reject all bids/ proposals.
