3. A complete Set of Bidding Documents may be purchased till November 22, 2021 @1500Hours by an interested bidder on submission of a written application and upon payment of a non-refundable fee of Rs. 2600/- (As per Direction by PPRA AJ&K) from the **office of the undersigned**.
4. Bids will issued only to eligible bidders or their representatives upon furnishing of application along with power of attorney/Authority Letter from the bidder.
5. Bidding Documents will be issued only to Contractor(s)/Firm(s) or their representative(s) having licensed by the Pakistan Engineering Council in the Category C-6 and above with Specialization Code CE-10 for the above mentioned work and should be duly enclosed by the **Office of Chief Engineer PWD Building/PHE (North) Go, AJK** having validity for FY 2021-22, who will submit original power of attorney along with original authority letter on stamp paper of Rs.100/- with each page attested by the Oath Commissioner.
6. Bids will be done on AJK CSR Neelum (4th Qtr April to June 2021) District Neelum, above /below/at par basis. Contractor has to write his bid in tender form both in figure upto 2 decimal (only two digits

after decimal will be considered). The condition of 2 digits after decimal will also apply in case of equal rates.

7. All bids must be delivered to the **“Office of the Executive Engineer Buildings/PHE Division, Division Neelum, AJK (Ph. # 05821-920029)”**. At or before 11:30Am, on November 23, 2021. The Bids will be opened at the time given above on same day, in the presence of bidder’s representatives who choose to attend at the same address, only the responsive bids will be considered. Bids received through Postal services will also be entertained.
8. All interested bidders must bring their original PEC registrations at the time of bid opening. Failure to do so will result in non-responsiveness.
9. In case the bidders quoted their rates equal to 10% or more than 10% below than Engineering Estimate, will have to provide additional Bid Security along with their bid in the Shape of CDR or Bank Guarantee from any Scheduled Bank of Pakistan/AJK equal to the amount of difference between the estimate and bid costs. Failure to do so will result in non-responsiveness.
10. The competent authority reserves the right to reject all the bids or any bid under the clause 33 of AJK PPRA Rules.
11. Each bidder shall sign each page of bid documents especially Form of Bid, failure to do so shall result in non-responsiveness.
