- Tender documents will issued only to the Constructor's/Firm's or their authorized representatives who will show original power of attorney along with original authority letter.
- 5. All bids must be accompanied by a Bid Security of amount as mentioned in column no.8. According to AJK PPRA Rule Clause No.25in shape of CDR issued by a schedule bank in Pakistan in favour of under signed and must be delivered to "The Executive Engineer PWD Building Division Mirpur AJ&K" before 11:30am on 29-11-2021.

Bids will be opened at 12:30 PM on the same day, in the presence of bidder's representatives who choose to attend at the same address. Incomplete and bid filled with led pencil will not be acceptable.

- The bidder should quote his rate in percentage above/below on the bases of "AJK CSR (April to June.) 2021 and non-schedule items rates must be quoted by contractor/ Firm. Contractor has to write his rates in figures, limiting upto two figures only after decimal point (any figure behind two figures after decimal point shall not be considered) the condition of two figures after decimal point will also applied in case of quoted
