A foreign bidder is entitled to participate in the bidding only if having a joint venture with any Pakistani Construction Firm in accordance with the relevant provisions of PEC bye-laws. Bidders desirous to bid as Joint Venture must get prior approval of the Employer for bidding as joint venture.

  - b) Original PEC License must be presented at the time of purchase of bidding documents.
  - c) Current litigation information on stamp paper.(Attested)
  - d) Valid Registration with PEC.
- iii. The Bid Security shall be, at the option of the bidder, in the form of Deposit at Call or a Bank Guarantee issued by a Scheduled Bank in Pakistan & Bank of AJK clearly mentioning the name of bidder from his own account in favour of the Employer/Executive Engineer PWD Highways Division Neelum valid for a period 28 days beyond the Bid Validity date.
- iv. The bidder should quote rates in **"Percentage Above/Below on the basis of AJKCSR"** and write his rates in figures, limiting to two figures only after decimal point (any figure beyond two figures after decimal point shall not be considered). The condition of two figures after decimal point will also apply in case of quoted rates.
- v. Bids received through Postal Services will not be entertained, Conditional, incomplete/Blanks and bids filled with led pencil will not be acceptable.
- vi. Bids will be opened by the Bid Opening & Evaluation Committee in the presence of Bidders or their representatives who choose to attend the following address.
