**INVITATION FOR BIDS**


The Govt. of AJ&K has allocated funds through ADP towards the cost of following projects. Bidding is open to all eligible bidders.

All bids (**Financial**) must be accompanied by a Bid Security in the amount of as mentioned in column no. 7 in shape of CDR issued by a schedule bank in Pakistan having its branches in AJK from bidder's own account in favour of under signed and must be delivered to the "Office of the Executive Engineer PWD PHE Division Kotli AJ&K" at or before **12:00Hrs** on **09-12-2021** (Bids will be opened at **12:30 Hrs**, by the bid opening & evolution committee in the presence of Bidders or their representatives who choose to attend. Bids received through postal service will not be considered, Conditional, Incomplete and bids filled with lead pencil will not be acceptable.
5. All bidders must fill in check list before submission of bid in their own interest as per Section-G of instructions to bidders which is a mandatory requirement.
6. The competent authority reserves the rights to reject all the bids or any bid under the clause 3 of AJK PPRA Rules.
