

**Bidding is open to all eligible Bidders**

- i. The Executive Engineer Building/PHE Division Haveli on behalf of the Employer invites sealed bids, Under AJK PPRA Rules 36(a) Single Stage-One Envelope Procedure, from eligible firms or constructors licensed by the Pakistan Engineering Council (PEC) for the year 2021-22 and duly endorsed by the Chief Engineer Building/PHE North/South Public Works Department AJK in the appropriate category with field of specialization as mentioned in column No.05 for the above works, Further detail/specifications of works above mentioned can be obtained from the office of the Undersigned during office hours up to **07-12-2021**.
- ii. A complete set of detailed documents of above work may be purchased by an interested bidder on submission of a written application with original documents to the office of Executive Engineer Building Division Haveli (Kahutta) upon payment of non-refundable fee
- iii. The Application must be accompanied by a declaration/Affidavit that he or his firm is not Black listed by any department of AJK & Pakistan
- iv. Bidding Documents will be issued only to constructor(s)/firm(s) or their authorized representative(s) who will show original power of attorney along with original authority letter and original PEC license.
- v. The bidders are required to submit their bid at 12:00 pm on **08-12-2021** in the office of the Undersigned. Bids will be open by the bid opening committee at 12:30 pm on the same day in the presence of bidders or their representatives who chose to attend. Incomplete and bid quoted with led pencil will be rejected.
- vi. The bidder should quote rates in "percentage above/below on the basis of AJKCSR" and write his rates in figures, limiting to two figures only after decimal point (any figure beyond two figures after decimal point shall not be considered) And item rate for none schedule items, for non schedule items bidder has to quote his rate in figures, limiting upto two decimal points. (Figures after two decimal points shall not be considered).
- vii. In case of the bidder quoted their rates more than 10% below than engineering estimate, will have to provide additional bid security along with their bid in the shape of CDR issued by a Schedule Bank in Pakistan having its branches in Azad Kashmir, equal to the amount of difference between the Estimated Cost and the Bid Cost. Failure to provide the said additional bid security with the bid, the bid shall be considered as non-responsive and rejected
- viii. All CDRs except successful bidder will be released after the verification from bank and as per procedure laid down in the bidding documents
- ix. The competent authority in accordance with PPRA Rule -33 reserves the right to reject all Bids proposal at any time prior to the acceptance of bid or proposal.
