- (i) Bidding is open to all the eligible bidders having workshop and repair services. ✓
- (ii) The interested **bidders** may obtain further information, inspect and acquire Tender Document from the office of the **Divisional Forest Officer Reforestation Division Neelum Valley, near District Complex Athmuqam, Ph. 05821-920010 during the office hours.** ✓
- (iii) A complete set of Tender Document may be purchased till **December 28, 2021 @ 3.00 PM** by an interested **bidder** on submission of a written application and upon payment of a non-refundable fee of Rs.500/- from the office of the **Divisional Forest Officer Reforestation Division Neelum Valley Ph. 05821-920010.** ✓
- (iv) Tender Form will be issued only to eligible **bidder's** or their representative upon furnishing of application along with power of attorney/ authority letter from the **bidder.** ✓
- (v) Tender documents will be issued only to **bidder** having Workshop and repair/replacement services. ✓
- (vi) The interested **bidder** shall submit 2% of bid price in shape of CDR as bid security. ✓
- (vii) All bids must be delivered to the office of the **Divisional Forest Officer Reforestation Division Neelum Valley Ph. 05821-920010** at or before 2:30 PM on **December 29, 2021.** The bids will be opened at 3:00 PM on **December 29, 2021** in the presence of bidders or their representative(s) who choose to attend at the same address. Only the responsive bids will be considered. ✓
- (viii) All interested bidders must bring their original **workshop documents** at the time of bid opening. Failure to do so will result in non-responsiveness. ✓
- (ix) Each bidder shall sign each page of Tender document especially Form of Bid, failure to do so shall result in non-responsiveness. ~~Failure to do so shall result in non-responsiveness.~~ ✓
- (x) The relevant **technical experience, Workshop and repair services, financial capability, past successful performance** on the part of bidder, shall be the eligibility criteria for technical evaluation. ✓
- (xi) The bidder must ensure that they submit all the required documents indicated in the Tender Documents without fail. Bids received without, undertakings, valid documentary evidence, supporting documents and the manner for the various requirements mentioned in the Tender Documents are liable to be rejected at the initial stage itself. ✓
