

**Hiring Of Consultancy Services For Equity Participation**

**From General Public/Private Sector**

The Bank of AJK intends to invite sealed bids under Rule 36(b) Single Stage Two Envelope Procedure from well reputed Sole Proprietors/firms/ companies (the Consultant) for Equity Participation from General public/private sector.

Interested eligible bidders may get the Bidding Document for aforementioned task after submission of written application along with tender fee Rs. 500/- in form of Bank Draft/Pay Order (Non-refundable) which shall be issued only during working hours immediately after publication of this tender from Establishment Section BAJK Head Office Muzaffarabad Azad Kashmir
2. Sole Proprietors/Firms/Companies should submit amount of 2% of bid Security refundable in case of non-successful bidder.
3. Tenders complete in all respects as laid down in the detailed Bidding Document would be considered.

The "Quality and Cost based Selection Method" will be adopted for the evaluation of financial proposals to be submitted, as per Single Stage Two Envelope bidding process, one envelope containing technical details etc. shall be clearly marked as "TECHNICAL PROPOSAL" and the other envelope containing the financial bids shall be clearly marked as "FINANCIAL PROPOSAL".
5. All the bidders should submit/deposit the complete tender by January 25, 2022 at 10:00 am at Establishment Section BAJK Head Office Muzaffarabad Azad Kashmir.
6. Technical Proposal will be opened in the presence of bidder's representatives who chose to attend at 10:30 am on the same date and venue.
7. Blacklisted firms /Companies/Suppliers/Distributers/Contractors/Bidders are prohibited for participation. All bidders shall furnish an affidavit/certificate that they are neither blacklisted nor in conflict with Government anywhere in territory of the State of the AJK, Federally Administrated Areas or Islamic Republic of Pakistan.
8. The Committee reserves the right to accept or reject any or all the bids as per AJK PPRA Rules.
