Bidding is open to all Eligible Bidders:

- I. A complete set of bidding documents may be purchased by an interested bidder on submission of a written application along with the following documents from the date of advertisement to 07-01-2022 during the office hours:
 - a. The cost of bidding documents shall be charged as per government's rates of tender fee plus prevailing taxes.
 - b. Original Power of Attorney along with Original Authority letter on stamp paper of Rs. 100/- with each page attested by the Oath Commissioner clearly mentioning the work for which Authority Letter is issued.
 - c. Original P.E.C License must be presented at the time of purchase of bidding documents.
 - d. A declaration/Affidavit that he or the firm is not blacklisted by any department of AJK/Pakistan and is not involved in any litigation with any Government Department on stamp paper of Rs. 100/- attested by the Oath Commissioner.
- II. All CDRs must be issued by a Schedule Bank of Pakistan having its branches in Azad Kashmir from regarding bidder's/firm's account. CDRs except successful bidder will be released after the verification from bank and as per procedure laid down in the bidding documents.
- III. The bid securities of unsuccessful bidders will return upon award of contract to the successful bidders or on the expiry of validity of bid, whichever is earlier.
- IV. The bidder should quote rates in percentage above/below on basis of AJK CSR and write his rate in figures, limiting to two figures only after decimal point (any figure beyond two figures after decimal point shall not be considered). The condition of two figures after decimal point will also apply in case of quoted rates.
- V. Bids will be received on 08-01-2022 at 11:00 AM and will be opened on the same day at 11:30 Hrs in the presence of bidders or their representative who will choose to attend. Conditional, incomplete and bids filled with led pencil will be non-responsive.
- VI. The Competent Authority reserves the rights to reject one or all bids under the clause 33 of AJK PPRA Rules 2017.
