Terms & Conditions:

- 1. The bidder must provide Valid/renewed certificate of registration with legal/recognized professional bodies, as well as having valid NTN certificate (active taxpayer list).
- Affidavit to the effect that the bidder is not blacklisted by public organization, nor bankrupted by any scheduled commercial banks as well as non-involvement in any litigation.
- 3. Bidding document containing complete specifications, quantity, terms and conditions can be obtained on payment of Rs. 1500/. (non-refundable fee) from the office of the undersigned, during working hours from 31 December 2021 to 07th January 2022.
- 4. Bids must be delivered at conference room of Directorate General Tourism at 11:00 hrs on 12 January, 2022 and the "Technical Proposal" shall be opened by the committee in the presence of Bidders or their authorized representatives who choose to attend the meeting of bid opening at the same address at 1200 hrs on the same day.
- 5. The "Financial Proposal of technically qualified bidder will be opened only.
- 6. **Technical Proposal** must include Firm's registration, Profile, experience proof, last 3 years printing specimens (Calendar, 4 color booklet printing etc.), without which the Firm shall be considered as non-responsive.
- 7. The bidder also includes High Resolution photographs of Landscape, religious and archaeological places of whole Azad Jammu Kashmir for calendars for printing along with Technical Proposal in hard and soft copy (data traveler), without which the Firm shall considered as non-responsive.
- 8. Bid Security (CDR) @ 2 % of total bid value in the name of Director General Tourism Go, AJK must be accompanied with Financial Bid/Proposal.
- 9. The bid must have six months (120 days) validity period.
