

**Invitation for Bid**  
**National Competitive Bidding**  
**1.0 MW Bhedi-Dhoba Hydropower Project**

Power Development Organization (PDO), Azad Jammu & Kashmir (the "Employer") intends to complete remaining civil works 1.0 MW Bhedi Dhoba Hydropower Project for which funds shall be received from Annual Development Budget Allocations of GoAJK. It is intended that part of the proceeds of these funds will be applied to eligible payments under the Construction Contracts for Civil work lots as follows:-

1.	<b>Lot No.1</b> Remaining civil works of weir, Protection of Power Channel, Forebay, Anchor Blocks and supports of penstock pipes and spill pipe, Power House and allied civil works as per bidding document.	Rs. 5000/-
2.	<b>Lot No.2</b> Remaining works of Approach road, Security post & Supply and Construction of Steel bridge etc. as per bidding documents.	Rs. 5000/-

1. The Employer now invites sealed bid under **Single-stage Single envelop** procedure from eligible experienced bidders licensed by the Pakistan Engineering Council (PEC) in the C6 and above category for the Works. The bidder can form a Joint Venture with other national firms and companies with total number of companies in the JV not more than two.
2. A complete set of Bidding Documents may be purchased separately for each lot of work on payment of prescribed tender fee (non-refundable) in form of bank draft in favor of under sign AJK PDO or on payment of cash amount by interested eligible bidders along with submission of a written application to Director Civil AJK PDO from **06<sup>th</sup> Jan, 2022 to 24<sup>th</sup> Jan, 2022.**
3. Bids must be accompanied by a Bid Security @2% of bid price as per Bid data sheet of bidding document in the form of Bank Guarantee from any schedule bank of Pakistan on the Bid Security Form included in the Bidding Documents or Call Deposit Receipt (CDR) issued by any schedule bank of Pakistan.
4. Sealed Bid shall be submitted at the office of undersign, Power Development Organization, AJ&K, Upper Chatter Housing Society, Muzaffarabad, Azad Jammu & Kashmir on **25<sup>th</sup> January, 2022 at 12:00 pm.** Bids shall be opened on the same day at **12:30 am** in the presence of bidders' representatives who choose to attend.
