The AJ&K Environmental Protection Agency (AJK-EPA) invites the Expression of Interest (EOI) from Individual Consultants, *on Single Stage – Two Envelop Bidding Procedure*, to carry out the consultancy work under the Project titled **“Hiring of Consultancy Services for ‘A STUDY – To Investigate & Assess the Cause of Infection of Mahseer Fish in Poonch River in Relation to 102 MW Gulpur Hydropower Project’”**. The Individual Consultants must be registered with Income Tax/Sales Tax Departments with active status on Active Taxpayers List of FBR, and CBR AJ&K. The Consultancy Firm shall be selected on *“Quality & Cost Based Selection Procedure”* as prescribed under Azad Jammu & Kashmir Public Procurement Regulatory Authority Consultancy Regulations, 2018.

The Expression of Interest (EOI) documents, containing detail of work, terms & conditions, selection & selection criteria, deadline & place of submission and opening of proposals are available for the interested firms at the office of the Director General, Environmental Protection Agency, AJ&K. The RFP detailed document may be obtained from **February 02, 2022**, till **February 15, 2022**, during the office hours, 08:30 A.M. to 04:00 P.M.

The price of EOI documents is Rs. 500 (Five Hundred), non-refundable, to be paid in the shape of Pay Order/Demand Draft/CDR in favor of DDO EPA-AJK.

The sealed Bids/Proposals, prepared in accordance with the instructions of EOI Document, accompanied by Bid Security @ 2%, must reach at this office latest by **February 17, 2022**, till 12:00 hours. The Bids/Proposals will be opened on the same day at 12:30 hours at office of Director General, Azad Jammu Kashmir Environmental Protection Agency, 2nd Floor AKLASC Building Complex Bank Squire, Chatter-Domail, Muzaffarabad.

Consultants blacklisted in AJK or Pakistan shall not be allowed to participate in the procurement of consultancy process under Rule-19 of AJK-Public Procurement Rules 2017. An affidavit should be attached with the Technical Proposal in this regard.

NTN registration and GST registration (if applicable) should be attached with the Technical Proposal.
