2. A complete set of Bidding Documents may be purchased till February 17, 2022 @ 16:30 Hours by an interested bidder on submission of a written application and upon payment of a non-refundable fee from the **office of the undersigned.**
3. Bids will be issued only to eligible bidders or their representatives upon furnishing of application along with power of attorney/Authority Letter from the bidder.
4. The interested bidders will have to submit filer certificate dully issued by Central Excise and Taxation Department at the time of purchase of bid document.
5. All bids must be delivered to Office of **The Conservator of Forests Muzaffarabad Circle Bank Road** at or before 11:30 AM, on February 18, 2022. The Bids will be opened at 12:00 PM on same day, in the presence of bidder's representatives who choose to attend at the same address. Only the responsive bids will be considered.
6. Firm/Individual also need to annex an affidavit with bid on judicial paper for Rs 100/- that firm/individual has never been blacklisted by any Government/Semi-Government institution.
7. The competent authority reserves the rights to reject all the bids or any bid under the clause 33 of AJK PPRA rules.
8. The contractor shall furnish to the Employer within fourteen (14) days after receipt of Letter of Acceptance or issuance of work order or before signing a formal contract whichever is earlier, a Performance Security at the option of the employer, in the form of CDR or Bank Guarantee from any schedule bank of Pakistan/AJK for the amount and validity specified in Contract Data.
