1. 2. All bids should be submitted in tape binding duly sealed. All documents should contain proper page marking, attached in sequence, should have signatures of authorized person. Moreover, signing and stamping of each page of bidding documents & form are mandatory, otherwise it will be **Rejected**.
3. Black listed Firms/Companies/Suppliers/Distributors/Contractors/Bidders are prohibited for participation and all bidders shall furnish an affidavit/certificate that they are neither black listed nor in conflict with Government anywhere in territory of the State of the AJK, Federally Administrated Areas or Islamic Republic of Pakistan.
4. Call deposit receipt for an amount minimum 3% of the total offered value in favor of **Deputy Director Admin SDMA Muzaffarabad Azad Kashmir** should accompany every quotation otherwise the offer will not be entertained.
5. Bid prices must be quoted on the relevant page of bidding document i.e., price schedule for the material to be offered, duly filled, signed and stamped by authorized representative of bidder, supported by the bid security.
6. Any bid prepared and submitted in contrary to the Terms & Conditions of the bidding shall be declared as non-responsive.
7. Quoted price of the offered items should include all enforced applicable taxes vogue in AJ&K.
8. The successful bidders shall be bound to supply the ordered items within 45 days from the date of issuance of work order.
