**Bidding is open to all eligible Bidders**

- i. The Executive Engineer Highways Division Bagh on behalf of the Employer, invites sealed bids under **AJK PPRA Rules 36(b) Single Stage-Two Envelope Procedure**, from eligible firms or contractors licensed by the Pakistan Engineering Council (PEC) and duly endorsed by Chief Engineer Highways North/South Public Works Department AJK in the appropriate category with field of specialization as mentioned in column No.4&5 for the above work(s).
- ii. The bidders are required to submit their Financial Proposals and Technical Proposals (sealed) in duplicate in separate envelopes, clearly marked as 'Original' and 'Duplicate' in a single envelop.
- iii. A complete set of bidding documents may be purchased by an interested bidder on submission of a written application to the above office along with 2%CDR issued by a Schedule Bank in Pakistan having its branches in Azad Kashmir in favor of the employer as earnest money as mentioned in column No. 8 and upon payment of a non-refundable tender fee as mentioned in column No.6 on or before **10-03-2022** during the office hours. The application must be accompanied by a declaration/affidavit that he or its firm is not black listed by any of the departments/ministries and it must also state the names of the works with costs, if any, allotted to him which are still under execution. Bidding documents will not be issued without this declaration/affidavit.
- iv. Tender Documents will be issued only to contractor(s)/firm(s) or their authorized representative(s) who will show original power of attorney along with original authority letter.
- v. Only eligible bidders with the following qualification should participate in the bidding process,
  - a) Has completed at least one contract of similar nature of work with a value of **PKR 110.000 million**, during the **last 03 years**.
  - b) Has an average annual turnover of minimum **PKR. 100.000 million**, during the last **03 years**.
- vi. Interested bidders desirous to bid as Joint Venture must get prior approval of the employer for bidding as joint venture. Without such approval, bidding documents will not be issued.
- vii. All CDRs except successful bidder will be released after the verification from bank and as per procedure laid down in the bidding documents.
- viii. The bidder should quote rates in "**percentage above/below on the basis of AJKCSR**" and write his rates in figures, limiting to two figures only after decimal point (any figure beyond two figures after decimal point shall not be considered). The condition of two figures after decimal point will also apply in case of quoted rates.

- ix. In case the amount of bid offered is less than the estimated cost by more than 10%, the bidder shall provide with the bid additional performance security in the shape of CDR issued by a Schedule Bank in Pakistan having its branches in Azad Kashmir, equal to the amount of difference between the Estimated Cost and the Bid Cost. Additional performance guarantee must be provided with financial bid at the time of submission of bid. Failure to provide the said additional performance security with the bid, the bid shall be considered as non-responsive and rejected.
- x. Bid must be delivered at the office of under signed on **11-03-2022** at or before **11:00 a.m.** Bids will be opened on **11-03-2022** at **11:30 A.M.** by the bid opening committee in the presence of bidder(s) or their representative(s) who chose to attend. Conditional, incomplete and bids filled with led pencil will not be acceptable
