The Executive Engineer PWD Highways Division Jehlum Valley on behalf of the Employer invites sealed bids in accordance within AJK PPRA Rules 36(a) Single Stage-Single Envelope bidding procedure from the eligible Firms/Contractors/Persons licensed by the Pakistan Engineering Council for the year, 2021-22 and endorsement in PWD AJ&K department in appropriate category mentioned against each work in column 5 below **with Specialization Code CE-01,CE-02** for the following works. A Foreign bidder is entitled to participate in the bidding only if having a joint venture with any Pakistani Construction Firm in accordance with the relevant provisions of PEC by-laws. Bidders desirous to bid as Joint Venture must get prior approval of the Employer for bidding as joint venture.

- ii. A complete set of Bidding Documents may be purchased by an interested bidder on submission of the following on or upto **05/03/2022** during office hours.
 - d) The bid security as mentioned in Column 6 issued from a schedule bank of Pakistan having its branches in Azad Kashmir Bank of AJK in favour of the Executive Engineer PWD Highways Division Jehlum Valley.
 - e) The cost of bidding documents shall be charged Rs. 1500/- as tender fee plus prevailing Taxes.
 - f) Original Power of Attorney along with original Authority Letter on stamp paper of Rs. 100/- with each page attested by the Oath Commissioner.
 - d) Original PEC License must be presented at the time of purchase of bidding documents.
 - e) Copy of bidder endorsement in the office of Employer.
 - f) "Black listed Firms / Companies / Suppliers / Distributors / Contractors / Bidders are prohibited for participation" and All bidders shall furnish an affidavit / certificate that they are neither black listed nor in Conflict with Government anywhere in territory of the State of the AJK, federally administrated Areas or Islamic Republic of Pakistan.
- iii. The Bid Securities of unsuccessful bidders will be returned upon award of contract to the successful bidder or on the expiry of Validity of Bid, whichever is earlier.
- iv. Bidding will be done "**Prevailing AJK-CSR District Jehlum Valley**" on "**Percentage (above/below) basis of AJKCSR**". Contractor has to quote the rates of Bid price in words and in digits and only two digits after decimal point will be considered.
- v. Performance security of contracts for smaller work up to 25 Million under clause 21.1.
- vi. Performance security of contracts for larger work above than 25 Million will be under clause 28.4 and 32.1.
- vii. All bids must be delivered at the **Office of the Executive Engineer PWD Highways Division Jehlum Valley Near Post Office Hattian Bala on 07-03-2022 at 11:30 am.** Bids will be opened on same date at 12:00 pm. Bids will be opened by the bid opening & evaluation committee in the presence of Bidders or their representatives who choose to attend. (Only one representative of a firm allowed to attend the bid opening due to COVID-19 SOP restrictions). Bids received through postal service will not be entertained. Conditional, incomplete and bids filled with lead pencil will not be acceptable.
