A foreign bidder is entitled to participate in the bidding only if having a joint venture with any Pakistani Construction Firm in accordance with the relevant provisions of PEC bye-laws. Bidders desirous to bid as Joint Venture must get prior approval of the Employer for bidding as joint venture.

- ii. A complete set of Bidding Documents may be purchased by an interested bidder on Submission of the following on or upto **14-03-2022** during office hours.
 - a) The bid security as mentioned in Column 6 issued from a schedule bank of Pakistan having its branches in Azad Kashmir or Bank of AJK in favour of Executive Engineer PWD Highways Division Neelum.
 - b) Original Power of Attorney along with original Authority Letter on stamp paper of Rs.100/- with each page attested by the Oath Commissioner. (in case of Authority)
 - c) Original PEC License for the year 2021-22 must be presented at the time of purchase of bidding documents.
 - d) Valid Registration with PEC with (CE-01 & CE-02) Code.
 - e) Firm duly endorsed in office of the Employer.
- iii. The bid securities shall be, at option of the bidder, in the form of Deposit at call or Bank Guarantee issued by a Scheduled Bank in Pakistan & Bank of AJK clearly mentioning the name of bidder from his own account in favor of the Employer/ Executive Engineer PWD Highways Division Neelum valid for a period 28 days beyond the Bid Validity date.
- iv. The bid securities of unsuccessful bidders will be returned upon award of contract to the Successful bidder or on the expiry of validity of Bid Security whichever is earlier.
- v. Bidding will be done on "Prevailing AJK- CSR District Neelum, on percentage (above/below) basis. Contractor has to Quote the rates of Bid price in words and in digits and only two digits after decimal will be considered.
- vi. Bids will be opened by the bid opening & evaluation committee in the presence of Bidders or their representatives who choose to attend the following address. Bids received through Postal Services will not be entertained. Conditional, incomplete and bids filled with led pencil will not be acceptable.
