Terms & Conditions.-

1. All bids must be accompanied by a Bid Security @ 2% of the total value of the bid in shape of CDR/Pay Order/Demand Draft in favor of '**DDO Azad Kashmir Transport Authority, Muzaffarabad**' (open cheques will not be entertained) as per AJK PPRA Rules. The Tender without 2% Bid Security shall be considered as Non-Responsive.
2. The opening of bids shall be '**Single Stage-Two Envelopes**' procedure in terms of Rule 36(b) of AJK Public Procurement Rules, 2017. The bid shall comprise a single package containing two separate envelopes. Each envelope shall contain separately the financial proposal and technical proposal.
3. The firm must have 2 years of relevant experience, the firm must be registered and based in Pakistan and should have outreach in the far flung areas like AJK. Interested firms by filing an application for obtaining RFP/Bidding Document shall be accompanied by a non-refundable fee in the shape of Pay Order/Demand Draft of value of Rs. 500 in favor of DDO Azad Jammu & Kashmir Transport Authority.
4. The bids must be reached at the address '**Office of Secretary Azad Jammu Kashmir Transport, Authority, Ground Floor, F-Block, District Complex, Old Secretariat, Muzaffarabad, AJK**' latest by **9th March, 2022** at **12:00 pm** that shall be opened on the same day at **12:30 pm** in the presence of bidders or their authorized representatives, who opt to attend.
5. Payment of the supplier will be made to the successful bidder after deduction of all taxes applicable in AJ&K and also after detail inspection & functionality of the equipments upon the confirmation of Technical/Purchase Committee of Azad Kashmir Transport Authority.
6. Black listed firms/companies/suppliers/distributors/contractors/bidders are prohibited for participation and all bidders shall furnish an affidavit/certificate that they are neither black listed nor in conflict with Government anywhere in territory of the State of Azad Jammu Kashmir, Federally administrated Areas or Islamic Republic of Pakistan.
7. The successful bidder has to provide equipment as per mentioned specifications or equivalent with total cost inclusive of all applicable taxes in AJ&K.
8. The competent authority may increase or decrease the quantity of above mentioned items as per Rule 42 c(iv) of AJK PPRA Rules, 2017.
9. The competent authority reserves the rights to reject all the bids or any bid under the Clause 33 of AJK PPRA Rules, 2017.
