3. For supply of electromedical equipment/instruments, wooden /steel furniture and bedding/ clothing etc. all manufactures/ authorized importers and authorized distributors/dealers can participate.
4. Bid Security (CDR) @ 3% of total bid value of quoted items in the name of Director General Health AJK Muzaffarabad must be accompanied with the financial bid. Cheques shall not be accepted.
5. Bids shall remain valid for **30.06.2022**.

9. All bidders (companies, firms, distributors, dealers) are directed to make registration with AJ&K Income Tax department otherwise, they will be considered as Non Filer in AJ&K. The name of firm should be in ATL of Azad Kashmir.
10. All taxes / duties levied by GoAJK will be charged from the bills under admissible rules.
11. All bids should be submitted in tape binding duly sealed. All documents should contain proper page marking, attached in sequence should have signatures of authorized person. Moreover, signing and stamping of each page of bidding documents/form are mandatory.
