
2. Bidding is open to all eligible Bidders which may obtain further information, inspect and acquire the Bidding Documents from the Office of the Executive Engineer PWD Building Division Rawalakot, District Headquarter Complex Poonch AJK.

3. A complete set of Bidding Documents may be purchased till 16-03-2022@ Office Hours by an interested bidder on submission of the following:
- Original power of attorney alongwith original authority letter on stamp paper of Rs: 100/- with each page attested by the oath commissioner.
  - Original PEC lincense must be presented at the time of purchase of bidding documents.
4. All bids must be delivered to the Office of the Executive Engineer PWD Building Division Rawalakot, District Headquarter Complex Poonch AJK at or before 1130 Hours, on 17-03-2022. The Bids will be opened at 1200Hours on same day, in the presence of bidder's representatives who choose to attend at the same address. Only the responsive bids will be considered.
5. The Bidders must quote rates in percentage above/below basis of AJK CSR and quote item rates for non-schedule/market items. Only two digits as they appear after decimal point will be considered. Any figure behind two digits after decimal points shall not be considered.
6. In case of the bidders quoted their rates equal to 10% or more than 10% below than Engineering Estimate, will have to provide additional bid security along with their bid in the shape of CDR or Bank Guarantee from any scheduled Bank of Pakistan/AJK equal to the amount of difference between the estimate and bid costs. Failure to do so will result in non-responsiveness.
7. Each bidder shall sign each page of bid documents especially Form of Bid, failure to do so shall result in non-responsiveness.
8. Competent authority reserves the rights to reject all the bids or any bid under clause 33 of AJK-PPRA rules.
