The bid must be submitted in separate sealed envelopes in accordance with PEC Guide Lines & AJK PPRA Rules-2017 for the following works:

- 1- Bidding documents can be purchased from undersigned office on submission of a written application along with Bid Security as mentioned in column No. 4 above. The Bid Security must be issued in shape of Call Deposit by any scheduled Bank of Pakistan/ BAJK, having its branch in Azad Jammu & Kashmir in favor of the undersigned's and upon payment of non-refundable tender fee. The application must be accompanied by a declaration/ Affidavit that the applicant or his firm is not blacklisted by any of the department/ ministries. Bidding documents will not be issued without this declaration.
- 2- Tender documents will be issued only to constructor(s) firm(s) or their authorized representative(s) who will show original power of attorney along with original authority letter.
Interested Bidders desirous to bid as joint venture must get prior approval of his joint Venture from the employer/ Director General Irrigation & Small Dams Muzaffarabad Azad Jammu & Kashmir. Bidding documents will not be issued without such approval.
- 3- A complete set of bidding documents will be issued to eligible bidders having following qualifications.
 - a) Firm/ Contractors has Completed at least one contract of similar nature of work during last five years with the minimum value of PKR 7.500 million.
- 4- The bidders must quote rates in percentage above/ below basis of AK CSR'. Only two digits as they appear after decimal point will be considered.
- 5- Bidders quoting rate equal to 10% or more than 10% below than the Engineer's Estimate will have to provide additional performance security along with their financial bid in the shape of CDR from any scheduled bank of Pakistan/ BAJK equal to the amount of difference between the estimated cost and quoted bid cost. Failure to do so will result in non-responsiveness.
- 6- The undersigned/ employer reserve the right to reject any or all bids without mentioning, the reasons as per clause IB.19 of bidding documents & AJK PPRA Rule 33.

- 8- All CDR's except successful bidders will be released after the verification from their concerned bank as per producer laid down in the bidding of documents.
