Call at deposit is mandatory and should be in the shape of security deposit, pay order or certified cheque for an amount of 4% estimated cost (in rupees) in favor of **Director General**, Civil Defence Muzaffarabad Azad Kashmir should necessarily be attached with the financial proposal, failure to which shall result in the rejection of the same. Bid prices must be quoted on the relevant page of bidding document i.e. price schedule for the material to be offered, duly filled, signed and stamped by authorized representative of bidder, supported by the bid security.
- 2. The rates shall remain firm up to the delivery of the quoted items.
- 3. Pre delivery inspection shall be carried out before taking over the ordered items.
- Quoted prices of the offered items should be mentioned in Lot and include all enforced taxes that included Income Tax, General Sales Tax, and Education Cess on the Income tax, Stamp duty &TQT.
- 5. The successful bidders shall be bound to supply the ordered items Equipment within 30 days, and Fabrication of Motorcycles into Bike Ambulance has to be completed and handed over on F.O.R Muzaffarabad within 45 days from the date of issuance of purchase order.
