



**INVITATION FOR BIDS**

The Executive Engineer PWD Highways Division Muzaffarabad on behalf of the Employer invites sealed bids in accordance within AJK PPRA Rules 36(a) Single Stage-Single Envelope bidding procedure from the eligible Firms/Contractors/Persons licensed by the Pakistan Engineering Council for the year, 2021-22 and endorsement in PWD AJ&K department in appropriate category mentioned against each work in column 5 below **with Specialization Code CE-01** for the following works. A Foreign bidder is entitled to participate in the bidding only if having a joint venture with any Pakistani Construction Firm in accordance with the relevant provisions of PEC by-laws. Bidders desirous to bid as Joint Venture must get prior approval of the Employer for bidding as joint venture.

**Bidding is open to all Eligible Bidders**

- i. Eligible Bidders may obtain further information, inspect and acquire the Bidding Documents from the **Office of Executive Engineer PWD Highways Division Muzaffarabad AJK Ph. No. 05822-920020**.
- ii. A complete set of Bidding Documents may be purchased by an interested bidder on submission of the following on or upto **24/03/2022** during office hours.
  - a) The cost of bidding documents shall be charged Rs. 1500/- as tender fee plus prevailing Taxes.
  - b) Original Power of Attorney along with original Authority Letter on stamp paper of Rs. 100/- with each page attested by the Oath Commissioner.
  - d) Original PEC License must be presented at the time of purchase of bidding documents.
  - e) Copy of bidder endorsement in the office of Employer.
  - f) "Black listed Firms / Companies / Suppliers / Distributors / Contractors / Bidders are prohibited for participation" and All bidders shall furnish an affidavit / certificate that they are neither black listed nor in Conflict with Government anywhere in territory of the State of the AJK, federally administrated Areas or Islamic Republic of Pakistan.
- iii. Bidding will be done "**Prevailing AJK-CSR District Muzaffarabad**" on "**Percentage (above/below) basis of AJKCSR**". Contractor has to quote the rates of Bid price in words and in digits and only two digits after decimal point will be considered.



All bids must be delivered at the **Office of the Executive Engineer PWD Highways Division I Block District Complex 2<sup>nd</sup> Floor Muzaffarabad on 25-03-2022 at 11:30 am**. Bids will be opened on same date at 12:00 pm. Bids will be opened by the bid opening & evaluation committee in the presence of Bidders or their representatives who choose to attend. (Only one representative of a firm allowed to attend the bid opening due to COVID-19 SOP restrictions). Bids received through postal service will not be entertained. Conditional, incomplete and bids-filled with lead pencil will not be acceptable.

- v. Serial No. 1 and other Serial Nos. will be consecutively open after interval of 15 minutes each.
- vi. The competent authority reserves the rights to reject all the bids or any bid under the Clause 33 of AJK PPRA Rules.
- vii. **“Evolution Report / Award of Contract shall also be displayed at AJK PPRA website”**


