The Executive Engineer PWD Highways Division Neelum on behalf of the Employer invites sealed bids in accordance within AJK PPRA Rules 36(a) Single Stage-Single Envelope bidding procedure from the eligible firms/contractors/persons licensed by the Pakistan Engineering Council for the year, 2021-22 and endorsed in PWD AJ&K department in appropriate category mentioned against each work in columns 5 below **with Specialization Code CE-01** for the following works. A foreign bidder is entitled to participate in the bidding only if having a joint venture with any Pakistani Construction Firm in accordance with the relevant provisions of PEC bye-laws. Bidders desirous to bid as Joint Venture must get prior approval of the Employer for bidding as joint venture.

**Bidding is open to all eligible Bidders**

- i. Eligible Bidders may obtain further information, inspect and acquire the Bidding Documents from the **Office of Executive Engineer PWD Highways Division Neelum AJK Ph. No. 05821-920057.**
- ii. A complete set of Bidding Documents may be purchased by an interested bidder on submission of the following on or upto **28/03/2022** during office hours.
  - a) The cost of bidding documents shall be charged Rs.1500/- as tender fee plus prevailing Taxes.
  - b) Original Power of Attorney along with original Authority Letter on stamp paper of Rs. 100/- with each page attested by the Oath Commissioner.
  - c) Original PEC License must be presented at the time of purchase of bidding documents.
  - d) Copy of bidder endorsement in the office of Employer.
  - e) "Black listed Firms / companies / Suppliers / Distributors / Contractors / Bidders are prohibited for participation" and all bidders shall furnish an affidavit / certificate that they are neither black listed nor in Conflict with Government anywhere in territory of State of the AJK, federally administrated areas or Islamic Republic of Pakistan.
- iii. Bidding will be done "Prevailing AJK- CSR District Neelum" on Percentage (Above/below) basis of AJK-CSR" Contractor has to quote the rates of Bid price in words and in digits and only two digits after decimal point will be considered.
- iv. All Bids must be delivered at **Office of Executive Engineer PWD Highways Division Neelum District headquarter Authmuqam District Neelum on 29/03/2022 at 11:30 am.** Bids will be opened on same date at **12:00 pm.** Bids will be opened by the Bid Opening & Evaluation Committee in the presence of Bidders or their representatives who choose to attend. (Only one representative of a firm allowed to attend the bid opening due to COVID-19 SOP restrictions). Bids received through Postal Services will not be entertained, Conditional, incomplete and bids filled with lead pencil will not be acceptable.
- v. Serial No.1 and other Serial Nos. will be consecutively open after interval of 15 minutes each.
- vi. The competent authority reserves the rights to reject all the bids or any bid under the Clause 33 of AJK PPRA Rules.
- vii. "Evolution Report / Award of Contract shall also be displayed at AJK PPRA website"
