4. Bidding will be done on " AJ&K CSR Bagh (April –Jun 2020-21) (As Per Notification) No P&DD/Gen/413-24/2021 Dated 20/12/2021 above / below basis contractor has to write his bid in tender from both in words and figured up to 2 decimals (only two digits after decimal will be considered)
5. Tender Documents will be issued only to constructor (s)/ Firm (s) who have performance satisfactory.
6. All bids securities of unsuccessful Bidders will be released after the verification from Bank and as per procedure laid down in Bidding Documents.
