5. The last date for submission of the bids 20/04/ 2022, 11:00am and bid opening shall take place at 11:30 am on the same day, at conference hall Tourism Complex Muzaffarabad.
6. Under AJK PPRA Rules procedure for open competitive bidding **Single Stage Two Envelope Procedure** will be adopted comprising as single package containing two separate envelopes, marked clearly as a " financial Proposal" and Technical Proposal" in bold and legible letters.
7. The Bid Security as mentioned in column 6 issued from of schedule Bank of Pakistan having its branches in Azad Kashmir/ Bank of AJK in favour of the Director General Tourism & Archaeology.
8. The Bidder must have three years of Tax return (GST & Income Tax Statements) and Bank statement and the relevant documents will also be made part of technical proposal.
9. The Bidder must holding NTN and registered in GST .
10. All prevailing taxes will be deducted from the invoice.
11. The payment will be made after testing and commissioning of work done at site as verified by the inspection committee.
