Invitation for Bids

Sealed bids are invited for procurement of Bulk Medicines during the financial year 2021-22, which will be received up to 13.04.2022(Wednesday) at 1200 Hrs in the office chamber of the Secretary Population Welfare, GoAJK Block No. 6, New Secretariat, Chattar, Muzaffarabad and will be opened on the same day at 12:30 Hrs in the presence of Bidders or their authorized representatives who choose to attend the meeting of bid opening.

- Bidding shall be conducted through Single Stage Two Envelopes bidding procedure of AJK Public Procurement Rules, 2017. The envelopes shall be marked as "TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL" in bold and legible letters. Financial Proposal of bids found technically nonresponsive shall be returned un-opened to the respective bidders.
- For supply of Pharmaceuticals all manufactures/authorized importers and authorized distributors can participate.
- 3. Bid Security (CDR) @ 2% of total bid value in the name of DDO Directorate General of Population Welfare AJK Muzaffarabad, must be accompanied with the Technical bid in sealed envelope. Cheques shall not be acceptable and shall render the documents non-responsive.
- Bids shall remain valid up to 30th June 2022.
- A complete set of Bidding document including detail specifications, Quantity, terms & Conditions can be obtained up to 13.04,2022 (Wednesday) on or before 12:00 hrs on submission of written request and may obtain soft copy through email (populationwelfareajk@yahoo.com) upon Payment of Rs. 3000/-(Rupees Three thousand) (Nonrefundable) to be deposited in government treasury Account No 101, SBP, Muzaffarabad as Bidding documents fee. - All taxes/duties levied by GoAJK will be charged from the bills as under rules.
- 7. All bids should be submitted in Tape Binding duly sealed. All documents should contain proper page marking, attached in sequence should have signatures of authorized person. Moreover, signing and stamping of each page of bidding documents/form are mandatory.
- 8. Soft copy of quoted rates must be attached with "FINANCIAL PROPOSAL" in the shape of CD or Flash Drive in same sealed envelope in which financial proposal is sealed.
