INVITATION FOR BIDS (IFB)

1. Local Government and Rural Development Department intends to procure Supply, Installation, Testing and Commissioning of Fire Fighting Equipment at Directorate General Office Building, Chattar, Muzaffarabad.

2. Sealed bids are invited from all eligible Bidders as per rule 36(a)/ 36(b) Single Stage-One Envelope meeting the following eligibility criteria:

a. Bidder must be Original Equipment Manufacturer (OEM) or OEM's authorized agent or firm of the offered product in Pakistan;

b. Bidder must have supplied, installed, tested and commissioned Fire Fighting system at minimum 02 verifiable organizations in Pakistan during last 03 (three) year;

c. Bidder must have verifiable presence in Islamabad, Rawalpindi, Lahore or anywhere in Azad Kashmir;

d. Bidder must have Annual Gross Turnover of at least four (04) million rupees, in any of last 03 (three) financial year;

e. Bidder must be registered with Income Tax/Sales Tax Registration and No. on Active Tax Payers List of FBR/Inland Revenue Department

f. Bidder shall not be blacklisted or in breach of performance with any Government Organization(s).
