1. Single Stage two envelope procedure is to be followed for the submission of the bid. The bid shall comprise a single package/ Main-envelope containing two separate envelopes consisting of the financial proposal and the technical proposal.

3. The bid Security, 5% of the bid price must be submitted with bid in the form of pay order/Bank draft in the name of Registrar High Court of Azad Jammu & Kashmir Muzaffarabad. No tender will be accepted without Bid Security and such tender(s) will be deemed rejected.
4. The bidder must be Survey/ Visit the site to prepare the solution before the submission of the bids on 28<sup>th</sup> April 2022 at 11:30 am.

Bid must be delivered to the address given below on or before 10<sup>th</sup> May 2022 at 12:00 Noon and Bidder will be open on the same day in the presence of bidders/ their authorized representatives at 12:30 PM. Financial Bids of only technically qualified firm will be opened after evaluation done by committee at High Court in presence of bidders. Date and time will be communicated accordingly.
6. Bidder must be an Original Equipment Manufacturer (OEM) or a direct authorized agent of the OEM of the offered camera models in Pakistan.
7. Bidder must not be blacklisted or in breach of performance with SBP or any Organization(s).
8. Bidder must have verifiable presence in Muzaffarabad/ Islamabad/Rawalpindi.
9. The offered products(s) must have been installed at minimum 03 verifiable organizations in AJ&K/ Pakistan during the last (05) financial years.
