- Executive Engineer PP&H Department Buildings Division Kotli** on behalf of employer's invites sealed bids, under AJK PPRA Rules 36(a) according to Single Stage, One Envelope Procedure (SSOE), from eligible firms or Contractors licensed by the Pakistan Engineering Council (PEC) and duly endorsed by the **Office of the Chief Engineer Building/PHE (South) Muzaffarabad Azad Jammu & Kashmir** in the appropriate category with the field of specialization as mentioned in column No. 7 for the above mentioned for Civil work.
- A complete set of Bidding documents may be purchased by an eligible bidder with the following qualifications:-
 - Bidding documents can be purchased from undersigned's office on submission of a written application along with upon payment of non refundable tender fee, as mentioned in **column # 6 for Civil Work & Column# 4 for Procurement Works** on or before **14-05-2022** during office hours, with requisite documents and declaration/affidavit that the applicant or his firms is not blacklisted by any of the department / ministries, Bidding document will not be issued without this declaration.
 - A Call on Deposit (CDR) amounting **3% of Bid Price civil work & 2% of Bid Quoted Price of Procurement Work** mentioned in **column # 5**, the interested Contractor(s) /firms must be provided at the time of submission of bid. The Call on deposit (CDR) must be issued by a schedule Bank of Pakistan, having its branches in Azad Jammu & Kashmir &the Bank of Azad Jammu & Kashmir.
 - Tender documents will be issued only to constructor(s) / firm(s) or their authorized representative(s) will show original PEC License power of attorney along with original authority letter for Civil Works.
- The bidder must quote rates in percentage above / below basis of **AJK-CSR (April – June) 2021 upto June, 30, 2022** for District Kotli and to quote item rates for non-schedule/ market items. Only two digits as they appear after decimal point will be considered. Any figures after two decimal points shall not be considered.

All Bids must be delivered at the office of **Executive Engineer PP&H Department, Buildings Division Kotli** Near **Shaheed Chowk** on dated **16-05-2022** at **12:30 Hrs.** Bids will be opened on same date **16-05-2022** at **01:15 Hrs.** as per time mentioned in **column# 10** in Civil Work & **Column# 8** in Procurement Works by the bid opening committee in the presence of bidder(s) or their representative(s) who chose to attend. Any bid if not accompanied by an acceptable **Bid Security** shall be rejected by the employer as non-responsive. The selector firm / Contractor(s) shall pay all Taxes levied in AJK.
- i. **(Special conditions for Procurements Works)**
- a) The only eligible manufactures / Suppliers / Authorized dealers, registered with Sale Tax and Income Tax deptt. Govt. of AJK / Pakistan can participate.
- b) Warranty will be claimed as per manufacture security and signed the Contract Agreement.
- c) All the required materials and equipments required for the procurement works mentioned in **Column # 2** will be provide at site mentioned by the **Executive Engineer PP&H Department, Buildings Division Kotli** Near **Shaheed Chowk** and no separate carriage will be paid.

6. The undersigned/ employer reserve the right to reject any or all bids along with mentioning the reason as per clause IB.30 of bidding documents and AJK PPRA Rule-33.
