

INVITATION FOR BID

AJK Power Development Organization (PDO), Azad Jammu & Kashmir (the "Employer") shall be provided funds from Annual Development Budget of GoAJK for development of 3.22 MW Narrdagian Hydropower Project. It is intended that part of the proceeds of these funds will be applied to eligible payments under the Engineering, Procurement and Construction Contract for DESIGN, MANUFACTURING, SUPPLY TO SITE, ERECTION, TESTING AND COMMISSIONING OF COMPLETE SET OF ELECTRO-MECHANICAL EQUIPMENT FOR 3.22 MW NARRDAGIAN HYDROPOWER PROJECT, DISTRICT JHELUM VALLEY, AJK.

1. The Employer now invites sealed bids (Technical & Financial Bids) in accordance with AJK PPRA Rules 2017 under single-stage two-envelop procedure from eligible experienced bidders licensed by the Pakistan Engineering Council (PEC) in the **C-3** category or above having specialized codes (EE03, EE04, EE05, ME03, ME04, ME05). A foreign bidder is entitled to bid only in joint venture with Pakistani / AJK constructor in accordance with the provision of PEC Bye-Laws.
2. Bidders may obtain further information, inspect at and acquire the Bidding Documents from the office of the Dy. Director (E&M), Power Development Organization, Upper Chatter Housing Society, Muzaffarabad and PEC valid Registration certificate.
3. A complete set of Bidding Documents may be purchased by interested eligible bidders, on submission of a written application to the undersigned and upon payment of a non-refundable fee of PKR 15,000 (rupees fifteen thousand) PKR in shape of bank draft in favor of Managing Director AJK PDO.
4. All bids (Technical) must be accompanied by a Bid Security of amount Rs. 8.0 Million as stipulated in bidding documents failing which the bids shall be out rightly rejected.
5. Sealed Technical & Financial Bids prepared in accordance with instructions given in the bidding document must reach at the office of Managing Director Power Development Organization, AJ&K, Upper Chatter Housing Society, Muzaffarabad, Azad Jammu & Kashmir on or before **6th June 2022, at 12:30 pm**. Technical bids shall be opened on the same day at 1:00 pm in the presence of bidder's representatives who choose to attend.
6. Employer has the right to reject all bids or proposals at any time prior to the acceptance of the bid or proposal (under AJK PPRA Rule 33).
