  - a) The bid security as mentioned in Column 6 issued from a schedule bank of Pakistan having its branches in Azad Kashmir Bank of AJK in favour of the Executive Engineer PWD Highways Division Muzaffarabad.
  - b) The cost of bidding documents shall be charged Rs. 1500/- as tender fee plus prevailing Taxes.
  - c) Original Power of Attorney along with original Authority Letter on stamp paper of Rs. 100/- with each page attested by the Oath Commissioner.
  - d) Original PEC License must be presented at the time of purchase of bidding documents.
  - e) Copy of bidder endorsement in the office of Employer.
  - f) "Black listed Firms / Companies / Suppliers / Distributors / Contractors / Bidders are prohibited for participation" and All bidders shall furnish an affidavit / certificate that they are neither black listed nor in Conflict with Government anywhere in territory of the State of the AJK, federally administrated Areas or Islamic Republic of Pakistan.
- iii. The Bid Securities of unsuccessful bidders will be returned upon award of contract to the successful bidder or on the expiry of Validity of Bid, whichever is earlier.
- iv. Bidding will be done "Prevailing AJK-CSR District Muzaffarabad" on "Percentage (above/below) basis of AJKCSR". Contractor has to quote the rates of Bid price in words and in digits and only two digits after decimal point will be considered.
- v. Performance security of contracts for smaller work up to 25 Million under clause 21.1.
- vi. All bids must be delivered at the Office of the Executive Engineer PWD Highways Division I Block District Complex 2<sup>nd</sup> Floor Muzaffarabad on 16-06-2022 at 11:30 am. Bids will be opened on same date at 12:00 pm. Bids will be opened by the bid opening & evaluation committee in the presence of Bidders or their representatives who choose to attend. (Only one representative of a firm allowed to attend the bid opening due to COVID-19 SOP restrictions). Bids received through postal service will not be entertained. Conditional, incomplete and bids filled with lead pencil will not be acceptable.

- Serial No. 1 and Other Serial Nos. will be consecutively open after interval of 15 minutes each.
