
### TERMS & CONDITIONS:-

1. The Bidding Document contains detailed specifications, instructions and conditions for those who intend to participate in the bidding process and are earnestly advised to read the Bidding Document before submission of their proposal / Bids which can be obtained through written application along with copy of PEC registration certificate to the undersigned on firm's letter Pad for a non-refundable cash payment of Rs. 3,000/- from the Office of the Directorate General Sports, Youth & Culture (Sports Stadium Muzaffarabad) till **06-07-2022** during the office hours.
2. All bids must be submitted in tape binding dully sealed.

3. Each lot bid shall be submitted by the interested firms in two separate envelopes marked as **"TECHNICAL PROPOSAL"** and **"FINANCIAL PROPOSAL"** in legible and bold letter. The Technical Proposal shall be opened on the day of bids opening and Financial Proposals shall be kept sealed in custody till final evaluation of the Technical Proposals. The Financial Proposals of only those firms, whom declared as technically qualified / responsive, shall be opened by the Departmental Purchase Committee (DPC) on the notified date and time, in the presence of representatives of the qualified / responsive firms / bidders.
4. Black listed Firms / manufactures / authorized dealers Bidders are prohibited for participation and all bidders shall furnish an affidavit / certificate that they are neither black listed nor in conflict with Government anywhere in territory of the State of the AJ&K, Federally Administrated Areas or Islamic Republic of Pakistan.
5. Call deposit for an amount minimum 3% of the total offered value in favour of Deputy Director / DDO Sports, Youth & Culture Muzaffarabad Azad Kashmir should be accompanied with Financial Bid otherwise the offer will not be entertained.
6. Bid prices must be quoted on the relevant page of bidding document i.e., price schedule for the equipments to be offered, dully filled signed and stamped by authorize representative of bidder, supported by the bid security.
7. Any bid prepared and submitted in contrary to the Terms & Conditions of the bidding shall be declared as non-responsive.
8. Quoted price of the offered items should include all enforced applicable taxes vogue in AJ&K.
9. The successful bidders shall be bound to supply the ordered items within 45 days from the date of issuance of work order.
10. The bids validity period shall be 120 days from the date of opening of the bids.
11. All Terms & Conditions mentioned in AJK PPRA Rules, 2017 shall be applicable on this procurement.
12. The Procuring Agency reserves the right to increase or decrease the quantity as per PPRA Rules, 2017.
13. A Performance Guarantee @ 10% of total amount must be submitted in shape of Bank Guarantee / CDR within 10 days after issuance of Letter of Acceptance (LoA).
