**INVITATION FOR BIDS**

The Executive Engineer PWD Highways Division Muzaffarabad on behalf of the Employer invites sealed bids in accordance within AJK PPRA Rules 36(a) Single Stage-Two Envelope bidding procedure from the eligible Firms/Contractors/Persons licensed by the Pakistan Engineering Council for the year, 2021-22 and endorsement in PWD AJ&K department in appropriate category mentioned against each work in column 5 below **with Specialization Code CE-01 & CE-02** for the following works. A Foreign bidder is entitled to participate in the bidding only if having a joint venture with any Pakistani Construction Firm in accordance with the relevant provisions of PEC by-laws. Bidders desirous to bid as Joint Venture must get prior approval of the Employer for bidding as joint venture.

**Bidding is open to all Eligible Bidders**

- i. Eligible Bidders may obtain further information, inspect and acquire the Bidding Documents from the **Office of Executive Engineer PWD Highways Division Muzaffarabad AJK Ph. No. 05822-920020.**
- ii. A complete set of Bidding Documents may be purchased by an interested bidder on submission of the following on or upto **05/07/2022** during office hours.
  - a) Written application on the official letter head of Firm / Company duly signed & stamped by the authorized person.
  - b) The bid security as mentioned in Column 6 issued from a schedule bank of Pakistan having its branches in Azad Kashmir /Bank of AJK in favour of the Executive Engineer PWD Highways Division Muzaffarabad.
  - c) The cost of bidding documents shall be charged Rs. 2000/- as tender fee plus prevailing Taxes.
  - d) Original Power of Attorney on stamp paper of Rs. 100 duly attested by Oath Commissioner in favour of authorized person to purchase the bid. The stamp paper shall be issued from the city of principal address of the firm as mentioned in PEC license.
  - e) Original PEC License must be presented at the time of purchase of bidding documents with code CE-02 for Sr. No. 1 & 2.
  - f) Copy of bidder endorsement in the office of Employer.
  - g) "Black listed Firms / Companies / Suppliers / Distributors / Contractors / Bidders are prohibited for participation" and all bidders shall furnish an affidavit / certificate that they are neither black listed nor in Conflict with Government anywhere in territory of the State of the AJK, and Islamic Republic of Pakistan.
- iii. The Bid Securities of unsuccessful bidders shall be returned upon award of contract to the successful bidder or on the expiry of Validity of Bid, whichever is earlier.



Bidding shall be done "Prevailing AJK-CSR District Muzaffarabad" on "Percentage (above/below) basis of AJKCSR". Contractor has to quote the rates of Bid price in words and in digits and only two digits after decimal point shall be considered.

All bids must be delivered at the **Office of the Executive Engineer PWD Highways Division I Block District Complex 2<sup>nd</sup> Floor Muzaffarabad on 06-07-2022 at 12:00 pm**. Bids shall be opened on same date at 12:30 pm. Bids shall be opened by the bid opening & evaluation committee in the presence of Bidders or their representatives who choose to attend. Only one representative of a firm allowed to attend the bid opening. Bids received through postal service shall not be entertained. Conditional, incomplete and bids filled with lead pencil will not be acceptable.

- vi. Serial No. 1 and Other Serial Nos. will be consecutively open after interval of 15 minutes each.
- vii. The Competent Authority reserves the rights to reject all the bids or any bid under the Clause 33 of AJK PPRA Rules.
- viii. "Evaluation Report / Award of Contract shall also be displayed at AJK PPRA website"
