

Invitation For Birds

District Livestock and Poultry Development Officer Rawalakot

Department of Animal Husbandry Azad Government of the State of Jammu & Kashmir intends procurement of Poultry Feed from well reputed income tax registered companies/firms/suppliers for financial years 2022-23, as enclosed subject to following terms and conditions:

1. Bidding shall be conducted through "Open Competitive Bidding" in pursuant to "Single Stage-Two envelop" Procedure Specified in the AJ&K PPRA Rules, 2017, 36(b). "Technical Bids" and "Financial Bid" should be mentioned clearly on the envelop. Technical bids will be opened first. "Financial Bids" of only technically qualifying bidders will be opened.
2. Sealed Bids must be delivered to District Livestock & poultry Development Officer District Poonch Rawalakot on or before 12:30 pm 04-07-2022
3. The bidder must provide a Bid Security Rs50000 along with the financial proposal in the form of CDR from Bank in favour of District Livestock and Poultry Development Officer Rawalakot. The bidder may be asked to Provide performance guarantee rate of 5 % of the contract Amount.
4. Bids will be opened in the presence of bidder or their representatives who choose to attend (along with Authority Letter) at in the District Livestock & poultry Development Office District Poonch Rawalakot on the 04-07-2022 at 14:00 pm
5. The bidders are required to submit their best and final prices Matching to the " Principle of Value for Money meaning Quality Product.
6. The quoted price shall be applicable for the whole financial year 2022-23.
7. The bidders Suppliers having the experience of at last two years with good performance certificate from procuring agency in the relevant Field of poultry supply will be preferred.
8. The bidder/ Suppliers must have their office and feed store at Rawalakot.
9. Taxes will be deducted as per applicable under AJ&K Tax Lawas and Government rules from amount billed for.
10. Specification of items with bidding from annexed herewith the advertisement notice for further classifications meant for Bid submissions or best value/price quotations.

Blacklisted Firms/companies/Suppliers /Distributors/Contractors/Bidders are prohibited for participation and all bidders Shall furnish an affidavit /certificate that they are nither blacklisted nor in Conflict with Government anywhere in territory of State of the AJK, federally administrated Areas or Islamic Republic of Pakistan.
12. Department Purchase Committee Reserves the right of accept or reject any bid under rule 33 of Aj&K PPRA Rules, 2017.

14. Successful bidder Shall have to Supply Poultry Feed(50kg packing) with certificate of feed formula Within 2 week after issuance of supply order on FOR basis.
