**Bidding is open to all Eligible Bidders**

- i. Eligible Bidders may obtain further information, inspect and acquire the Bidding Documents from the **Office of Executive Engineer PWD Highways Division Bagh AJK Ph. No. 05823-920071 & Fax No 05823-920072.**
- ii. A complete set of Bidding Documents may be purchased by an interested bidder on submission of the following on or before **02-07-2022** during official office hours.
  - a) Written application on the official letter head of Firm / Company duly signed & stamped by the authorized person.
  - b) The bid security as mentioned in Column 6 issued from a schedule bank of Pakistan having its branches in Azad Kashmir and Bank of AJK in favour of the Executive Engineer PWD Highways Division Bagh should be submitted at the time of purchasing of Tender.
  - c) The cost of bidding documents shall be charged Rs. 1500/- as tender fee, plus prevailing Taxes.
  - d) Bidding Documents will be issued only to the Contractor(s)/Firm(s) on their representative(s) who will submit original Power of Attorney along-with Authority letter on stamp paper of Rs. 100 duly attested by the Oath Commissioner in favour of authorized person who purchase the bid. The stamp paper should be issued from the city of principal address of the firm as mentioned in PEC license.
  - e) Original PEC License with the required specialization code & copy of Bidder Endorsement by the Office of the Employer should be presented at the time of purchase of bidding documents.
  - f) "Black listed Firms / Contractors / Bidders are prohibited for participation" and all bidders shall furnish an affidavit / certificate that they are neither black listed nor in litigation with Government Department anywhere in the State of AJK and Islamic Republic of Pakistan.
- iii. The Bid Securities of unsuccessful bidders will be returned upon award of contract to the successful bidder or on the expiry of Validity period of Bid, whichever is earlier.
- iv. Bidding will be done "**Prevailing AJK-CSR District Bagh**" on "**Percentage (above/below) basis of AJKCSR**". Contractor has to quote the rates of Bid price in words and in digits and only two digits after decimal point will be considered.
- v. All bids must be delivered at the **Office of the Executive Engineer PWD Highways Division Bagh on 04-07-2022 at 11:30 am**. Bids will be opened on same date at 12:00 pm in the presence of Bidders or their representative who chose to attend at the same address. Bids received through postal service shall not be entertained. Conditional, incomplete bids filled with lead pencil will not be acceptable.
- vi. All the bidders must fill in check list before submission of their bid in their on interest as per section IB11.1(a) of bidding data sheet which is a mandatory requirement.
- vii. Any bid prepared and submitted in the contrary to the section "**C&D**" respectively of Bidding Documents as mentioned in the instruction to Bidders shall be declared as non-responsive.

- viii. The Employer reserves the rights to reject all the bids or any bid under the Clause 33 of AJK PPRA Rules.  
ix. "Evaluation Report / Award of Contract shall also be displayed at AJK PPRA website"
