INVITATION FOR BIDS

1. Sealed Tenders through Single Stage-Two Envelope (SSTE) bidding procedure are hereby invited against the approved Development Scheme of "Construction of Jail Building Rawalakot (Phase- II)" from all the contractors/firms, who are registered for current financial year with Pakistan Engineering Council (PEC) & endorsed in PP&H, AJK PWD for Financial year 2022-23 in the category C-4 and above with Specialization Code CE-10. The technical & financial bids must be submitted in separate sealed envelopes with PEC guide lines & AJK PPRA Rules 2017 for the following works.

2. Bidding documents can be purchased from undersigned's office on submission of a written application along with CDR amounting to PKR: 2,036,000/- as mentioned in column No.5. The CDR must be issued by a Scheduled Bank of Pakistan, having its branch in Azad Jammu & Kashmir in favour of the Employer as earnest money and upon payment of non-refundable tender fee, as mentioned in column No.6 on or before 14-09-2022, during office hours. The application must be accompanied by a declaration/Affidavit that the applicant or his firm is not blacklisted by any of the department/ministries. Bidding documents will not be issued without this declaration.
3. Tender Documents will be issued only to constructor(s)/firm(s) of their authorized representative(s) who will show original power of attorney along with original authority letter.
4. Interested bidders desirous to bid as joint venture must get prior approval of his joint venture from the employer/Chief Engineer Building/PHE (North) Muzaffarabad Azad Jammu & Kashmir. Bidding documents will not be issued without such approval.
5. A complete set of biddings documents will be issued to eligible bidders having following qualification
- Firm/Contractor has completed at least two contracts of similar nature of work with the minimum value of PKR: 54.28 Million within last 5 years.
 - Firm/Contractor has an Average Annual Turnover of PKR 44.00 Million for last 3 years.
6. The Bidders must quote rates in percentage above/below basis of AJK CSR and to quote item rates for non-schedule/market items. Only two digits as they appear after decimal point will be considered. Any figure behind two digits after decimal points shall not be considered.
7. Pre bid meeting will be held in the office of the Executive Engineer PWD Building Division Rawalakot on 07-09-2022 at 1100 Hrs.

The Bidders are required to submit their Financial & Technical bids (sealed) in separate envelopes, clearly marked as ORIGINAL and Duplicate in a single envelope before 1130Hrs on 15-09-22. Technical bid will be opened by the bid opening committee at 1200Hrs on the same day in office of the Executive Engineer PWD Building Division Rawalakot in the presence of bidders or their representative who choose to attend at the same address. After scrutiny and evaluation of the technical bids, the financial bids of only qualified bidders will be opened for which a separate date will be fixed and will be intimated to all qualified bidders in writing, by the office of the Executive Engineer PWD Building Division Rawalakot. Financial bids of unsuccessful bidders will be returned un-opened.


9. Conditional, incomplete and bid filled with led pencil will not be acceptable.
