1. Item wise rate of all items must be entered. Supplier must quote rate with name of country/company / other origin of brand separately.
2. Bid must be accompanied by 50,000/- (Rupees Fifty Thousand only) as bid security (Call Deposit/Bank Guarantee); otherwise bid will not be entertained.
3. Bid Documents are available after this publication and may be obtained upon payment in cash Rs. 1000.00 against written request from the office of AJ&K Medical College Muzaffarabad during working hours.
4. Date and Stamp of the firm must be entered on sealed bids. Incomplete bids will not be entertained.
5. The offered rates will be applicable from date of issuance of supply order to till completion of supply by the supplier and no request for enhancement of rates will be accepted.
6. The supply will be made within the time specified in the Supply Order.
7. After delivery of consignment Inspection Committee will inspect the equipment according the specification and if it is not accordingly, the supply will be rejected and lifted by the firm at its own risk and cost.
8. Quoted rates must be inclusive of all taxes; rates exclusive of taxes will not be entertained.
9. All taxes/duties levied in AJ&K will be deducted from the total value of the bill at the time of the payment.
10. At least 01 year free after sale service (where applicable) will be the responsibility of the successful bidder.
11. In case Tyres become out of order up to minimum running 25000 KM, supplier must rectify the problem within 15 days and not rectifiable tyres will be replaced at the risk and cost of supplier.
12. Black listed and banned companies./firms will not be entertained.
13. Incomplete/conditional bid and bid bearing cutting/over writing without authentication will not be considered.
14. The committee reserves right to accept or reject any or all bids as per AJ&K PPRA Rules.
