(Under Single Stage-Single envelope Procedure)

The Executive Engineer PWD Highways Division Rawalakot on behalf of the Employer invites sealed bids in accordance with AJK PPRA Rules 36(a) Single Stage-One Envelope bidding procedure from eligible firms/contractors/persons licensed by the Pakistan Engineering Council for the year 2021-22 and endorsement in our department in appropriate category mentioned against each work in columns 5 below with Specialization Code CE-01 for the following works. A foreign bidder is entitled to participate in the bidding only if having a joint venture with any Pakistani Construction Firm in accordance with the relevant provisions of PEC bye-laws. Bidders desirous to bid as Joint Venture must get prior approval of the Employer for bidding as joint venture.

- I. Eligible Bidders may obtain further information, inspect and acquire the Bidding Documents from the Office of Executive Engineer PWD Highways Division Rawalakot AJK Phone & Fax No. 05824-920144.
 - II. A complete set of Bidding Documents may be purchased by an interested bidder on submission of the following on or before 26/09/2022 during official office hours.
 - a) Written application on the official letter head of firm/Company duly signed & stamped by the authorized person.
 - b) The bid security as mentioned in Column 6 issued by a schedule bank of Pakistan having its branches in Azad Kashmir Bank of AJK in favour of the Executive Engineer PWD Highways Division Rawalakot should be submitted at the time of purchasing of tender.
 - c) The cost of bidding documents shall be charged Rs. 1500/- as tender fee plus prevailing Taxes.
 - d) Bidding documents will be issued only to the contractor(s)/Firm(s) on their representative(s) who will submit original Power of Attorney along with authority letter on stamp paper of Rs 100 duly attested by Oath Commissioner in favour of authorized person who purchase the bid. The Stamp paper should be issued from the city of principal address of the firm as mentioned in PEC license. Original Power of Attorney along with original Authority Letter on stamp paper of Rs. 100/- with each page attested by the Oath Commissioner.
 - e) Original PEC License with the required specialization code & copy of bidder endorsement by the office of the Employer should be presented at the time of purchase of bidding documents.
 - f) Black listed Firms/Contractor/Bidders are prohibited for participation & all bidders shall furnish an affidavit/ certificate that they are neither black listed nor in litigation with government department anywhere in the State of AJK & Islamic Republic of Pakistan.
 - III. The bid securities of unsuccessful bidders will be returned upon award of contract to the successful bidder or on the expiry of Validity of Bid, whichever is earlier.
 - IV. Bidding will be done on "prevailing AJK-CSR District Poonch, on percentage (above/below) basis. Contractor has to quote the rates of Bid price in words and in digits and only two digits after decimal point will be considered.
 - V. All bids must be delivered at the Office of the Executive Engineer PWD Highways Division Rawalakot A Block District Complex 3rd floor Rawalakot on 27-09-2022 at 11:30am & opened upto 12:00 Pm at same day in the presence of Bidders or their representatives who choose to attend at the same address. Bids received through postal service will not be entertained. Conditional, incomplete and bids filled with led pencil will not be acceptable.
 - VI. All the bidders must fill in checklist before submission of their bid in their on interest as per section IB11.1(a) of bidding data sheet which is a mandatory requirement.
 - VII. Any bid prepared & submitted in the contrary to the section "C&D" respectively of bidding documents as mentioned in the instruction to bidders shall be declared as non-responsive.
 - VIII. The Employer reserves the rights to reject all the bids or any under the clause 33 of AJKPPRA Rules.
 - IX. "Evaluation Report/Award of Contract shall also be displayed at AJKPPRA website.
