Tender Notice for Renovation of Zonal Office & Branch at Rawalakot AJK (Single stage Two Envelope Method).

The Bank of Azad Jammu Kashmir (the "Procuring Entity") invites the technical and financial bids as per AJKPPRA Rule 36 (b) Single stage Two envelop from reputed firms/contractor for the Project titled **RENOVATION OF ZONAL OFFICE & BRANCH AT RAWALAKOT AJK**, having adequate experience in carrying out the projects of similar nature.

- 1) The Procuring Entity invites sealed bids from eligible firms or persons Valid and Active licensed by the Pakistan Engineering Council. Bidders may obtain further information from, inspect at and acquire the bidding documents from the office of the Divisional Head Operation, Head Office Bank Square Chatter Muzaffarabad AJ&K, before 17th October 2022 in office working hours.
- 2) A complete set of Bidding Documents may be obtained by an interested bidder's on submission of a written application to the above office and upon payment of a non-refundable fee Rs. 2000/- of Printing Charges in shape of CDR on the name of Bank of AJ&K. for "RENOVATION OF ZONAL OFFICE & BRANCH AT RAWALAKOT AJ&K". Up to 17th October 2022 during office working hours from the office of **Divisional Head Operation Bank of Azad Jammu & Kashmir Muzaffarabad**.
- 3) Under single stage two envelop procedure the sealed envelope containing Technical & Financial bids (Should be clearly marked as Technical & Financial Bids) as per the requirement given in the bidding document and Technical & financial Bid must be submitted to the office of the Divisional Head Operations at or before 18th October 2022 up to 3:30 Pm through courier or registered mail (**No bid will be received by hand**) the same will be opened at 4:00 Pm on the same day in the presence of bidder's/ representatives who choose to attend, in the office of the Divisional Head Operation, Head Office Bank Square Chatter Muzaffarabad AJ&K.
- 4) All bids must be accompanied by a Bid Security in the shape of Call Deposit from Bank of Azad Jammu & Kashmir or Bank of Pakistan (Not pay order), in the amount of Rs. 250000/- in the name of Bank of Azad Jammu & Kashmir
- 5) Pre bid meeting will be held on 5th October 2022, at 11:00 am at the Committee room of Bank of Azad Jammu & Kashmir Head Office Muzaffarabad.
- 6) Application received after the closing date shall not be entertained for Technical & Financial evaluation.
- 7) Financial Bid must be quoted inclusive of all Taxes.
- 8) Valid NTN/GST registration certificate must be provided with the Technical Bid.
- 9) The firm must apply on its own independent profile not a JV arrangement. Application proposing JV will not be accepted.
