2. Financial Proposal of bids found technically non-responsive shall be returned un-opened to the respective bidders.
3. For supply of electromedical equipment/instruments, Regent Rental Laboratory Equipment all manufactures/ authorized importers and authorized distributors/dealers can participate.
4. Bid Security of quoted items in the name of Medical Superintendent Cath Lab & Cardiac Surgery Hospital, Muzaffarabad must be accompanied with the financial bid. Cheques shall not be accepted.
5. Bids shall remain valid for **30.06.2023**.
