Invitation for Bids

Sealed bids are invited for procurement of Dental medicines/materials and Dental X-ray films against the Normal budget of 3 million for Jinnah Dental Hospital AJ&K Health Department during the financial year 2022-23, which will be received up to **05.01.2023 at 11:30 am** in the Jinnah Dental Hospital Go AJ&K Muzaffarabad and will be opened on the same day at 12:00 pm in the presence of bidder or their authorized representatives who choose to attend the meeting of bid opening.

1. Bidding shall be conducted through Single Stage - Two Envelopes bidding procedure of AJK Public Procurement Rules, 2017. The envelopes shall be marked as **"TECHNICAL PROPOSAL"** and **"FINANCIAL PROPOSAL"** in bold and legible letters. Financial Proposal of bids found technically non-responsive shall be returned un-opened to the respective or bidder.
2. For supply of Dental medicines/materials and Dental X-ray Films etc. Authorized Importers and Authorized Distributors supplier can participate according to technical criteria mentioned in the bidding document.
3. Bid Security (CDR) @ 3% (90,000) of total bid value of quoted items in the name of Executive Director Jinnah Dental Hospital Muzaffarabad AJK must be accompanied with the financial bid. **Cheque shall not be accepted.**
4. Bids shall remain valid for 30.6.2023.
5. A complete set of Bidding document including detailed specifications, quantity, terms & conditions and evaluation criteria can be obtained upto **04.01.2023** on or before duty hours on submission of written application and upon payment of Rs. 2000/- (Rupees two thousand) Non-refundable in shape of cash or bank draft as bidding document fee from Store Incharge Jinnah dental Hospital (Mobile No (03460483488) Email. jinnahdentalhospital@gmail.com from the office of the Executive Director Jinnah Dental Hospital Muzaffarabad AJK.
6. All taxes/ duties levied by GoAJK will be charged from the bills under admissible rules.
7. All bids should be submitted in tape binding duly sealed. All documents should contain proper page marking, attached in sequence should have signatures of authorized person. Moreover, signing and stamping of each page of bidding documents are mandatory.
8. All bidders shall furnish an affidavit /certificate that they are neither black listed nor in conflict with government anywhere in territory of the State of Azad Jammu & Kashmir, Federally administrated areas and provinces of Islamic Republic of Pakistan.
9. Bid Evaluation Report and Award of Contract shall also be displayed on AJKPPRA web site.

11. All bidders (companies, Firms, Distributors Dealers) are directed to make registration with AJ&K income tax department otherwise, they will be considered as Non Filer in AJ&K.
