- iv. Bidding will be done on "CQR (Contractor to Quote)"basis. Contractor has to quote the rates of Bid Price in words as well as in digits and only two digits after decimal point will be considered.

Bids will be opened on same day (Serial # 1) at 12:00 PM & (Serial # 2) at 12:15 PM in the presence of Bidders or their representative who chose to attend at the same address. Bids received through postal service shall not be entertained. Conditional, incomplete bids filled with lead pencil will not be acceptable.
- vi. All the bidders must fill in check list before submission of their bid in their on interest as per section IB11.1 (a) of bidding data sheet which is a mandatory requirement.
- vii. Any bid prepared and submitted in the contrary to the section "C&D" respectively of Bidding Documents as mentioned in the instruction to Bidders shall be declared as non-responsive.
- All the other terms & conditions are available in the Bidding Documents of each work.

- ix. The Employer reserves the rights to reject any or all the bids under the Clause 33 of AJK PPRA Rules.
