The Executive Engineer PWD Highways Division Sudhnuti (Pallandri) on behalf of the Employer invites sealed bids in accordance with AJK PPRA Rules 36(b) **Single Stage-Two Envelope** bidding procedure from the eligible firms/contractors/persons licensed by the Pakistan Engineering Council in appropriate category mentioned against each work in columns 5 below **with Specialization Code CE-01 & CE10** for the following works. A foreign bidder is entitled to participate in the bidding only if having a joint venture with any Pakistani Construction Firm in accordance with the relevant provisions of PEC bye-laws. Bidder's desirous to bid as Joint Venture must get prior approval of the Employer for bidding as joint venture.


Bidding is open to all eligible Bidders

- i. Eligible Bidders may obtain further information, inspect and acquire the Bidding Documents from the **Office of Executive Engineer PWD Highways Division Sudhnuti (Pallandri) Ph. No. 05825-920015 upto 21/01/2023 during office hours. ie 03:00 pm.**
- ii. A complete set of Bidding Documents may be purchased by an interested bidder on submission of following.
 - a) Bidding documents may be purchased @ Rs. 10000/- as tender fee plus prevailing Taxes.
 - b) Original Power of Attorney along with original Authority Letter on stamp paper of Rs.100/- with each page attested by the Oath Commissioner.(in case of Authority)
 - c) Original PEC License for the year 2022-23 must be presented at the time of purchase of bidding documents.
 - d) Valid Registration with PEC with CE-01 & CE-10 Code.
 - e) Firm duly endorsed in office of the Employer.
- iii. The bid securities shall be, at the option of the bidder, in the form of Deposit at call or Bank Guarantee issued by a Scheduled Bank of Pakistan or Bank of AJK clearly mentioning the name of bidder from his own account in favour of the Employer/ Executive Engineer PWD Highways Division Sudhnuti Pallandri valid for a period 28 days beyond the Bid Validity period.
- iv. The bid securities of unsuccessful bidders will be returned upon award of contract to the successful bidder or on the expiry of validity of Bid Security whichever is earlier.
- v. Bidding will be done on "**CQR (Contractor to Quote)**"basis. Contractor has to quote the rates of Bid Price in words as well as in digits and only two digits after decimal point will be considered.
- vi. All bids must be delivered at the **Office of the Executive Engineer PWD Highways Division Sudhnuti (Pallandri) on 25/01/2023 at 11:30 AM.** Bids will be opened on same date at 12:00 PM in the presence of Bidders or their representative who chose to attend at the same address. Bids received through postal service shall not be entertained. Conditional, incomplete bids filled with lead pencil will not be acceptable.

- vii. All bidders must fill in check list before submission of bid in their own interest as per section G of instruction to bidders. Which is a mandatory requirement.
- vii. A pre-bid meeting shall be held in office of the Executive Engineer PWD Highways Division District Complex Sudhnuti (Pallandri) on **19/01/2023 at 11:00 am.**
- ix The competent authority reserves the rights to reject all the bids or any bid under the Clause 33 of AJK PPRA Rules.
