**INVITATION FOR BIDS**

**(Under Single Stage-Single Envelope Procedure)**

The Executive Engineer PWD Highways Division Bhimber on behalf of the Employer invites sealed bids in accordance within AJK PPRA Rules 36(a) Single Stage-Single Envelope bidding procedure from the eligible Firms/Contractors/Persons licensed by the Pakistan Engineering Council for the year 2022-23 and endorsement in PWD AJ&K department in appropriate category mentioned against each work in column 5 below with Specialization Code CE-01 for the following works. A Foreign bidder is entitled to participate in the bidding only if having a joint venture with any Pakistani Construction Firm in accordance with the relevant provisions of PEC by-laws. Bidders desirous to bid as Joint Venture must get prior approval by the Employer for bidding as joint venture.

**Bidding is open to all Eligible Bidders**

- i. Eligible Bidders may obtain further information, inspect and acquire the Bidding Documents from the Office of Executive Engineer PWD Highways Division Bhimber AJK Ph. No. 05828-923500.
- ii. A complete set of Bidding Documents may be purchased by an interested bidder on submission of the following on or before 06-02-2023 during official office hours from office of the undersigned.
  - a) Written application on the official letter head of Firm / Company duly signed & stamped by the authorized person.
  - b) The cost of bidding documents shall be charged as mentioned in column 6 above as tender fee, plus prevailing Taxes in shape of bank draft attach with application.
  - c) Bidding Documents will be issued only to the Contractor(s)/Firm(s) on their representative(s) who will submit original Power of Attorney along-with Authority letter on stamp paper of Rs. 100 duly attested by the Oath Commissioner in favour of authorized person who purchase the bid. The stamp paper should be issued from the city of principal address of the firm as mentioned in PEC license.
  - d) Original PEC License with the required specialization code & copy of Bidder Endorsement by the Office of the Employer should be presented at the time of purchase of bidding documents.
  - e) "Black listed Firms / Contractors / Bidders are prohibited for participation" and all bidders shall furnish an affidavit / certificate that they are neither black listed nor in litigation with any Government Department anywhere in the State of AJK and Islamic Republic of Pakistan.

- iii. The Bid Securities of unsuccessful bidders will be returned upon award of contract to the successful bidder or on the expiry of Validity period of Bid, whichever is earlier.
- iv. Bidding will be done on “CQR (Contractor to Quote)” basis. Contractor has to quote the rates of Bid Price in words as well as in digits and only two digits after decimal point will be considered.
- v. All bids must be delivered at the **Office of the Executive Engineer PWD Highways Division Bhimber on 09-02-2023 at 11:30 AM**. Bids will be opened on same day (Serial # 1) at 12:00 PM, (Serial # 2) at 12:15 PM & (Serial # 3) at 12:30 PM in the presence of Bidders or their representative who chose to attend at the same address. Bids received through postal service shall not be entertained. Conditional, incomplete bids filled with lead pencil will not be acceptable.
- vi. All the bidders must fill in check list before submission of their bid in their on interest as per section **IB11.1 (a)** of bidding data sheet which is a mandatory requirement.
- vii. Any bid prepared and submitted in the contrary to the section “C&D” respectively of Bidding Documents as mentioned in the instruction to Bidders shall be declared as non-responsive.
- viii. All the other terms & conditions are available in the Bidding Documents of each work.
- ix. The Employer reserves the rights to reject any or all the bids under the Clause 33 of AJK PPR Rules.
