


**Project:**

Tender Notice for Renovation of Chella Bandi Branch at Muzaffarabad  
AJ&K (Single Stage Two Envelope Method)

The Bank of Azad Jammu and Kashmir the procuring entity invites the technical and financial bids as per AJKPPRA **Rule 36 (b) Single Stage Two Envelopes** from reputed Firms/Contractor for the project titled **Renovation of Chella Bandi Branch at Muzaffarabad AJ&K**, having adequate experience in carrying out the projects of similar nature.

- 1) The Procuring Entity invites sealed bids from eligible firms or persons. Valid and Active licensed by Pakistan Engineering Council. Bidders may obtain further information from, inspect at and acquire the bidding documents from the office of the **Establishment Section, Operations Division, Head Office Bank Square Chatter Domel Muzaffarabad AJ&K** before 18th April 2023 during the office hours.
- 2) A complete set of Bidding Documents may be obtained by an interested bidder's on submission of a written application to the above office and upon payment of a non-refundable fee of Rs. 2000/- (on the name of BAJK) of printing charges in shape of CDR on the name of Bank of AJ&K for project **Renovation of Chella Bandi Branch at Muzaffarabad AJ&K** up to 18th April 2023 during office working hours from the office of **Establishment Section, Operations Division, Head Office Banks Square Chatter Domel Muzaffarabad AJ&K.**
- 3) Under Single Stage Two Envelope Procedure the sealed envelope containing Technical and Financial bids (Should be clearly marked as Technical and Financial bids) as per the requirement given in the bidding document and Technical and Financial bid must be submitted to the office of the Establishment Section, Operations Division BAJK Head Office on or before 19th April 2023 up to **12:00 PM** through courier or registered mail (**No bid will be received by hand**) the same will be opened at **12:30 PM** on the same day in the presence of bidders/representatives who choose to attend in the office of Establishment Section, Operations Division, Head Office Banks Square Chatter Muzaffarabad AJ&K.
- 4) All bids must be accompanied by a Bid Security in the shape of Call Deposit Receipt from Bank of Azad Jammu and Kashmir or Bank of Pakistan (Not pay order), in the amount of Rs. 250,000/- in the name of Bank of Azad Jammu and Kashmir.
- 5) Pre bid meeting will be held on 10th April 2023 at **11:00 AM** at the committee room of Bank of Azad Jammu Kashmir Head Office Muzaffarabad.
- 6) Application received after the closing date shall not be entertained for Technical and Financial evaluation.
- 7) Financial Bid must be quote inclusive of all taxes.
- 8) Valid NTN/GST registration certificate must be provided with the Technical Bid.
- 9) The firm must apply on its own independent profile not a JV arrangement. Application proposing JV will not be accepted.
