The stamp paper should be issued from the city of principal address of the firm as mentioned in PEC license.

Original PEC license with the required specializations code & copy of Bidder C. Endorsement by the office of the Employer should be presented at the time of purchase of bidding documents.

- d. "Black listed firms/ Contractor / Bidder are prohibited for participation" and all bidders shall furnish an affidavit / certificate that they are neither black listed nor in litigation with any Government Department anywhere in the State of AJK and Islamic Republic of Pakistan.
- All bids (Financial) must be accompanied by a Bid Security in the amount as mentioned in column 3. no. 8 in shape of CDR issued by a schedule bank in Pakistan having its branches in AJK from bidder's own account in favor of under signed and must be delivered to the "Office of the Executive Engineer PWD Building Division Mirpur AJ&K" at or before 11:00 Am on 29-04-2023. Bids will be opened at the time given in Column # 7, on the same day, in the presence of bidder's representatives who choose to attend at the same address.
