Purchase of vitamin/mineral premix

Food Department of AJ&K invites sealed bids for procurement of 30 Metric Ton vitamin/mineral premix (Iron, Folic Acid, Zinc and Vit. B12) for wheat flour fortification from reputable and well established manufacturers/companies/firms/suppliers/contractors/ distributors/ who must be registered with Government of Fakistan for Sales/NTN and Professional Taxes. Bids should reach by 05th May 2023_at 12:00 hours in the office of Director Food AJ&K House # 151-D Salellite Town Rawalpindi. These bids will be opened on the same day at 12:30 hours in the presence of Bidders or their authorized representatives.

- Rates of premix should be provided per Kilogram basis in PKR.
- Bidding shall be conducted through Single Stage- two envelopes procedure of AJ&K PPRA rules 2017.
 The envelopes shall be marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters. Financial proposal of bids found technically non-responsive shall be returned unopened to the respective <u>bidders</u>.
- The Bid Security amounting to Rs. 3.0 million call deposit must be accompanied in the name of Director Food AJ&K.
- All taxes/duties levied by GoAJ&K will be deducted from the bills under admissible rules.
 All bids should be submitted in Taxe Right.
 - All bids should be submitted in Tape Binding. All documents should contain proper page marking, attached in sequence should have signatures of authorized person. Moreover, signing and stamping of each paper of bidding document/form is mandatory.
- A certificate must be attached with the bid that the firm/ supplier is not black listed or debarred from any Government or its organization or project.
- The established manufactures/companies/firms/suppliers/contractors/distributors who wants to take part in this bid should have submit their annual return at-least of rupees 50.00 million his certified annual return from his bank.
