### **Invitation for Bids**

Scaled bids are invited for procurement of Eye equipment/instruments & Furniture during the financial year 2022-23, against development Schemes "Prevention and Control of Blindness in AJ&K" which will be received up to **18.05.2023 at 10:30 a.m** in the office chamber of the Secretary Health, GoAJK Block No. 10, New Secretariat, Chatter, Muzaffarabad and will be opened on the same day at 11:00 a.m in the presence of bidders or their authorized representatives who choose to attend the meeting of bid opening.

1. Bidding shall be conducted through Single Stage - One Envelope bidding procedure of AJK Public Procurement Rules.
2. For supply of Eye equipment/instruments, wooden /steel furniture etc, all manufactures/ authorized importers and authorized distributors/dealers can participate.
3. Bid Security (CDR) amounting Rs. 5,50,000/- in the name of Director General Health AJK Muzaffarabad must be accompanied with the financial bid. Cheques shall not be accepted.
4. Bids shall remain valid for **30.06.2023**.

7. All bidders shall furnish an affidavit /certificate that they are neither black listed nor in conflict with government anywhere in territory of the state of Azad Jammu & Kashmir, federally administrated areas and provinces of Islamic Republic of Pakistan.
8. Evaluation report and award of contract shall also be displayed on AJ&K PPRA web site.
9. All bidders (companies, firms, distributors, dealers) are directed to make registration with AJ&K Income Tax department otherwise, they will be considered as Non Filer in AJ&K. The name of firm should be in ATL of Azad Kashmir.
10. Soft copy of technical specifications of quoted item must be kept in Technical Bid envelope in shape of Flash drive.
11. All taxes / duties levied by GoAJK will be charged from the bills under admissible rules.
12. All bids should be submitted in tape binding duly sealed. All documents should contain proper page marking, attached in sequence should have signatures of authorized person. Moreover, signing and stamping of each page of bidding documents/form are mandatory.
