1. A complete set of Bidding Document may be purchased by an eligible bidder for the above on submission of a written application to the Director General Sports, Youth & Culture along with CDR as mentioned in column No. 06 issued by scheduled Bank of Pakistan, having its branches in Azad Jammu & Kashmir and the Bank of Azad Jammu & Kashmir in favor of the DDO Sports, Youth & Culture and upon payment of non-refundable tender fee Rs. 1500/- for each package till 22-05-2023 during the office hours.

- 2. Application must be accompanied by a declaration / affidavit that he or it's firm is not blacklisted by the Department of AJK / Pakistan and is not involved in litigation with any Government Department. Bidding Documents will not be issued without this declaration.
- Bidding Documents will be issued only to the Contractor's / Firm's or their authorized representatives who will show original power of attorney along with original authority letter & original PEC Registration Certificate.
- 4. The bidders are required to submit their bid at 11:00Am on 22-05-2023. Bids will be opened on the same day at 11:30Am by the bid opening committee in the office of the Director General Sports, Youth & Culture situated at Sports Stadium Muzaffarabad in the presence of the bidders or their representatives who choose to attend conditionally. Incomplete and bid filled with led pencil will not be acceptable.
- 5. The bidder should quote his rate in percentage above / below on the basis of AJK-CSR and quote item rates for non-schedule/market items. Contractor has to write his rates (quoted and above / below) in figures, limiting upto two decimal places only.
- 6. The bidders quoting rates equal to 10% or more than 10% below, that the Engineering Estimates will have to provide additional CDR along with their bid issued from any scheduled Bank of Pakistan / AJK and the Bank of Azad Jammu & Kashmir equal to the amount of difference between the estimated cost and quoted bid cost. Failure to do so will result in non-responsiveness / disqualification.
- 7. The Contractors / Firms are bound to visit the sites before submitting their bids.
- All CDR's except successful bidders will be released after the due verification and as per procedure laid down in the Bidding Documents.
- 9. The bidder must write the Name of Project, Name of District and Package No. on the envelope.
- 10. The completion time of each project is 120 days.
- 11. This tender notice is also available on AJK PPRA's website www.ppra.ajk.gov.pk.
- The competent authority in accordance with PPRA Rule-33 & IB 19 reserves the right to accept or reject any one or all Bids.
